## ANC Directed Award Contracting Option

As ANC subsidiaries and a Small Business Administration (SBA) certified 8(a) companies, direct awards up to \$25 million (\$100 million for Department of Defense (DoD)\*) may be accepted without formal justification and are not restricted by the normal 8(a) directed award ceiling (FAR 19.808-1). A sole source procurement to an ANC under the provisions of FAR 19.805-1(b)(2) and 13 CFR 124.506(b) provides a streamlined and flexible procurement strategy.

- Directed awards are non-protestable (13 CFR 124.517)
  - Reduces procurement cycle timelines
  - Offers transparency in cost and price negotiation

*\* Fiscal Year (FY) 2020 National Defense Authorization Act, Section 823 raises the justification and approval (J&A) threshold to \$100,000,000 for DoD. No justification and approval is required for DoD-awarded sole-source 8(a) contracts under \$100,000,000.*
