

Direct Award Contracting Option

As an ANC subsidiary and a Small Business Administration (SBA) certified 8(a) company, ChESS may accept direct awards up to \$25 million (\$100 million for Department of Defense (DoD) without formal justification and is not restricted by the standard 8(a) direct award ceiling (FAR 19.808-1). ChESS is eligible for direct awards under their NAICS where the small business size standard is based on the number employees.

A sole source procurement to ChESS under the provisions of FAR 19.805-1(b)(2) and 13 CFR 124.506(b) provides a streamlined and flexible procurement strategy.
